



## scientific support

Cell Detox is a full-spectrum detoxification formula that protects cell membranes, DNA and other body proteins from the damaging effects of free radical toxins and dietary food toxins. It contains plant and cruciferous extracts that protect against liver toxins and exercise-induced toxins by delivering a blend of amino acids, vegetable and fruit extracts, along with natural source Catalase and S.O.D.

Body Detox supports healthy detoxification for the entire body. It provides natural magnesium salts, activated charcoal, fiber and a botanical blend of fenugreek, peppermint leaf, ginger root and fennel seed to promote effective elimination of toxins without the use of laxatives. These two formulas combine to create Detox System to offer a gentle, effective and safe way to remove intra and extracellular toxins.

- L-Cysteine plays a role in protecting DNA, and other body proteins, from being damaged and easily oxidized by free radicals. Cysteine detoxifies heavy metals and it also activates many important functions of the immune system. Cysteine has high affinity for heavy metals and will bind tightly to metals such as lead cadmium, mercury and arsenic so they can be excreted from the body<sup>5,6,7</sup>.
- L-Glycine supports healthy sleep cycles, and poor sleep can affect immunity and generate toxic inflammatory markerses8.
- L-Glutamine can act as a respiratory fuel and can enhance the function of stimulated immune cells. L-Glutamine modulates the immune system and plays a role in keeping ammonia toxicity down by being a nontoxic transporter of ammonia in the blood circulation<sup>9,10</sup>.
- Lactobacillus acidophilus detoxifies two mycotoxins: ochratoxin A (OTA) and patulin (PAT) which are abundantly found in human foods. Lactobacillus acidophilus helps protect people against the adverse health effects of these compounds by reacting with them and neutralizing them<sup>11</sup>.
- Dandelion, Milk Thistle, Cabbage Leaf powder, MSM (as OptiMSM®) and L-Glutathione play a role in detoxifying the liver by keeping the liver damage markers, ALT and AST down. They can also be liver-protective by blocking cell membrane damage. They all have antioxidant activities<sup>12,13,14,15,16</sup>.
- Organic Chlorella, Organic Spirulina, Catalase and Superoxide Dismutase (S.O.D.) reduce free radical toxins. Both Spirulina and Chlorella have the ability to neutralize dietary toxins<sup>17,18,19,20</sup>.
- Seventy percent of Americans and Europeans are Magnesium deficient. This is a critical situation where toxicities can occur because Magnesium is essential for producing Glutathione Peroxidase, the first line of defense against free radicals<sup>22,23</sup>. Magnesium protects against heavy metal toxicity, and is an essential detoxifier of lead, mercury and arsenic mainly through production of Glutathione Peroxidase and Metalloproteinases<sup>24</sup>.

- Activated Charcoal is a potent detoxifying agent, even when excess toxins were created by intentional acetaminophen overdose in human volunteers<sup>25</sup>. Activated Charcoal treatment speeds up the elimination of environmental toxins, and toxicities caused by medication such as Digoxin in patients who were treated with it. Activated Charcoal reduced the Digoxin half-life removal time from 68 hours to an average of 36 hours. In controlled situations, filtration of bodily fluids using Activated Charcoal can actually remove toxic inflammatory cytokines rapidly and effectively<sup>26,27</sup>.
- Psyllium husk binds to metals, such as excess free iron, which is known to be a free radical generator, causing hydrogen peroxide in the body to be converted into the highly toxic hydroxyl radical<sup>28</sup>.
- Psyllium fiber has the additional benefits of being a well-known bulk laxative that helps prevent the resorption of Cholesterol in the G.I. Tract<sup>29</sup>.
- Flaxseed consumption lowers Oxylipins, inflammatory markers that are formed as a by-product when fatty acids are digested. In older people (45 to 64 years old), Oxylipins are two or more times higher than in younger people (19 to 28 years old). After 4 weeks of Flaxseed consumption, 7 out of 10 older people had their Oxylipin levels normalized, while 3 people still had elevated Oxylipins<sup>30</sup>.
- Glucomannan has synergistic properties with dietary Chromium; both support healthy blood lipid levels. Glucomannan minimizes the dangerous postprandial insulin surge by up to 50% that can occur after meals. It works as a dietary fiber that slows the absorption of carbohydrates so insulin spikes are minimized and its toxic effects are lessened<sup>31,32</sup>.
- -Fenugreek and Ginger were tested side-by-side in a clinical trial. Ginger decreased platelet aggregation and Fenugreek mildly lowered after-meal glucose spikes during the 3-month study<sup>33</sup>.
- In 2014, a meta-analysis of human trials using Fenugreek Seed confirmed the earlier results and concluded that Fenugreek strongly lowered after-meal (postprandial) glucose spikes<sup>34</sup>.
- A 2013 detailed study with Ginger Root showed that it improved insulin sensitivity as shown by reduced insulin levels. In the same study, Ginger supported a healthy lowering of LDL-Cholesterol by 24% from 89.2 to 67.8 mg/dL35.
- Peppermint Leaf, its extracts and essential oils have been used traditionally and in the modern era to support good colon health. A systematic review and meta-analysis showed that Peppermint oil was effective in supporting colon health in 4 trials involving 392 people<sup>36</sup>.
- Fennel has a protective effect on bone cells. Bone cell metabolism is a dynamic balance between bone resorption and new bone cell formation. Fennel extract at low micromolar doses causes bone stem cells to grow and differentiate into new bone cells<sup>37</sup>.
- Fennel and its constituent anise have shown phytoestrogen activity and have been tested for natural estrogenic activity with positive results. Fennel has traditionally been used for its androgenic activity<sup>38</sup>.

## use, dose, and interactions

USE/DOSAGE: Cell Detox: Take 2 capsules daily, 30 minutes before a meal with water or as directed by your qualified healthcare practitioner. Body Detox: Take 2 capsules daily one hour before bedtime with water or as directed by your qualified healthcare practitioner.

INTERACTIONS: Detox System contains complex blends of botanicals, amino acids and nutrients and can impact the efficacy and potency of prescription medication and supplements. If you are currently on medication, please consult with your prescribing physician prior to taking this product as it can alter the efficacy of prescription medications. #### Can I take Detox System every day?

Yes, this product was designed to be a daily use product.

#### Can Body Detox be taken closer to bedtime than 1 hour before?

This has more to do with comfort than science. If you swallow something and lay down, you may feel like it's not moving. If you drink water before bed, you may need to go to the restroom in the middle of the night. Body Detox works best if taken before bed because it will encourage bowel movement in the morning, which is a good time to eliminate for many people. If you can't take Body Detox at night for some reason, it's certainly okay to take it during the day.

#### The label says the product contains glutathione (GSH), how is it absorbed and where does it come from?

GSH contained in the new formulation is food grade, meaning that the body can absorb it in this form. It is not necessarily something that stimulates your body to produce glutathione. It actually is glutathione as you would find it in healthy foods like raw dairy products. It has enzymes, it has probiotics, and it has an amino acid sequence that helps guide the glutathione into the cells that it needs to be via the receptor sites.

#### Is it safe to be used by children under the age of 18?

This product is formulated for adults, not children.

#### Is it safe to take it with prescription medication?

We recommend that you do not take this product within 1-2 hours before/after taking medication.

#### What is Charcoal "A Supra"?

"A Supra" is a brand of activated charcoal. We are using the same ingredient, from a different source.

#### What is a hypromellose capsule?

This is a veggie capsule. It is non-animal and suitable for vegetarians.
